Signage at new location discussed and it was decided to hold off until we are situated as it's only been a month. However we can get something on the digital road sign.

The role of Bill (Town Rep), Claudette (MODL Rep) and Trevor (BPD Rep) are to bring information to the Chamber and how we can all work together for businesses in our area. Bill says he is here to hear from businesses. The Chamber used to have a huge input in the Town's budget process. More business needs to be done at general membership meeting. Need to give notice on topics being discussed at general membership meetings.

We need to know what businesses need and look for to set up a business and locate in our area. We need to have a strong Chamber to represent business.

7. Bus for Bridgewater

Currently suggesting 2 routes – 2 bus 2 route and a single loop. The single loop received the most votes at the open house. The goal is to serve both employees and day to day people. It was noted that through the International Student program the biggest complaint is that there is no transportation system here. The province has a public transit assistance program which the Town will apply for funding. Depending on the route that is decided commuters could be possible to reach areas outside of Town limits. The question was asked whether there could be a trial period with a smaller bus to see how much use it would get before a huge investment is made. Jessica will forward the info from the Jan 23 meeting.

Health Services Presentation

The radiothon this year will raise money for OR equipment and raises money for SS and Fishermans. The goal is to raise \$175,000 to replace 7 key pieces of equipment.
